

Booking Terms and Conditions

Booking a Driving Tour:

In order to reserve your place on a tour, a deposit of \$500 per person is payable upon booking unless otherwise noted in the tour description. In booking the tour you guarantee full payment to GT Car Tours of the total tour value.

GT Car Tours will confirm your booking via email. The remaining balance outstanding must be paid no later than eight (8) weeks before the start of the tour (if this date has already elapsed then full payment is due upon reserving a place on the tour).

If full settlement is not received by the due date, GT Car Tours reserves the right to cancel the booking in line with the charges as detailed in "Cancellation made by you."

Paying a deposit is deemed to be an acceptance of both the booking conditions and the terms and conditions of booking on a tour.

Methods of Payment:

You may pay both the deposit and balance by check, credit card, debit card, or electronic transfer. Please allow enough time for the funds to clear by the payment due date.

What's Included:

Unless stated otherwise on the tour itinerary, fees include hotel accommodation, breakfast, evening meal, and driver information packet.

What's Excluded:

All add-on costs are excluded. Examples of add-on costs are:

- Hotel – drinks, papers, room service and any items you order while at the accommodation are your responsibility. You must pay off in full any outstanding accounts before checking out.
- Other: – other examples of add on costs which are your responsibility are those relating to, breakdown, other accommodation and meals outside those included in the tour package, fuel, tolls and personal acquisitions.

Age:

In order to participate you must be age eighteen (18) or over at the time of booking.

Changes to the Tour:

Changes made by you:

- If you request, GT Car Tours will endeavor to make any minor amendments to your booking.

- Any amendments must be notified to GT Car Tours as soon as possible. If GT Car Tours is able to implement the changes an administration fee of \$ 50 per person will be charged in addition to any further direct add on costs.
- If the changes you propose are beyond “minor” then GT Car Tours reserves the right to treat the amendment as a cancellation of the booking in line with the terms and conditions set out in “Cancellation Made by You.”

Changes made by GT Car Tours:

- Although rare, from time-to-time GT Car Tours may need to make amendments to your booking.
- Owing to the nature of bookings made with third parties months in advance, changes are sometimes unavoidable. You will be notified as soon as possible of any necessary changes.

Cancellation of the Tour:

Cancellation made by you:

- If you cancel your booking on a tour, you must notify us in writing as soon as possible.
- You will be liable for charges for cancellation as follows:

NOTICE PERIOD AND CANCELLATION CHARGE

Period before tour start date that written notification is received,
and amount owed as a percentage of the total tour cost:

More than eight (8) weeks – 50%

Less than eight (8) weeks – 100%

Cancellation made by us:

GT Car Tours reserves the right to cancel your tour under any circumstances.

If an alternative equivalent tour is available, GT Car Tours will first offer you the option to go on this (and allow you to use your booking fee dollar-for-dollar for another tour). Otherwise you are entitled to a full refund of all money received from you up to the time of the cancellation.

Termination:

In the interest of all concerned, GT Car Tours reserves the right to prohibit your participation in the tour if it becomes aware of any illegal, inappropriate or antisocial behavior at their sole discretion.

If this condition is enforced, you will in no circumstances be entitled to any refund of the booking fees and GT Car Tours will not be held responsible for any additional costs you incur as a result of your termination.

Third Party Tours:

Tours run in conjunction with a named third support (*e.g.*, car dealers and car clubs), are wholly controlled and run as GT Car Tours and all appropriate terms and conditions apply between GT Car Tours and those booking the tour. The third party promotion merely constitutes voluntary support of the tour and does not form any part of the contract between GT Car Tours and its customers.

If the third party removes their support for whatever reason (*e.g.*, personal injury, business closure or even through choice), unless GT Car Tours notifies you otherwise, this will in no way infringe in any way the ability of the tour to proceed. GT Car Tours will, given the time scale available, seek to replace the support that the third party has withdrawn and appoint an appropriate substitute. Please note it may not be possible to replace third party support should insufficient time be available to GT Car Tours.

Should GT Car Tours cancel a tour due to the removal of a third-party's support, all clients' monies will be refunded in full.

If you decide to withdraw from a tour due to the withdrawal of third-party support, you will be governed by the charges set out in "Cancellation made by you."

Force Majeure:

If events such as war or threat of war, riot, civil strife, terrorist activity, or actual threatened terrorist activity, industrial dispute, natural or nuclear disaster, pandemic, adverse weather conditions, fire, and all similar events outside our control, GT Car Tours will not be liable to you for a refund of any booking fee already paid or any other expenses or charges incurred by you. It may be possible for you to obtain insurance to guard against any loss under these circumstances.

Legal Compliance:

It is your responsibility to ensure you abide by all statutory laws and regulations of any area through which a tour travels. These include, without limitation, to your regard to speed limits, the legality of your vehicle (*e.g.*, taxes, insurance, registrations), and not driving under the influence of any intoxicating substances.

You must hold a full valid driving license and passport if applicable.

You are in no way allowed to compete or race with other guests.

You are entirely responsible for your own behavior and in no way can GT Car Tours be held responsible by you or any third party if you undertake in any illegal or antisocial behavior. You will therefore indemnify and hold harmless GT Car Tours in full against any attempt by third parties to bring about any claim as a result of any breach by you of any laws, regulations, or applicable standard of care during your participation on the tour.

Travel Delays:

It is the nature of making bookings in advance that prearranged events may be delayed for reasons out of the control of GT Car Tours. Any travel delays both before and during the tour, whether foreseen or not, can in no way be deemed to be the responsibility of GT Car Tours and therefore GT Car Tours will not be liable for any extra costs you may incur. Examples of such costs include, but not limited to, hotels, rental cars, meals and drinks.

These conditions apply regardless of the how the delays were brought about.

Examples include, but not limited to, adverse weather conditions, natural disasters, technical difficulties, and industrial disputes. For whatever reason you are unable to complete the tour you will in no circumstances be entitled to any refund for any unused services booked on your behalf.

Travel Insurance:

It is your responsibility to ensure you have the appropriate travel insurance in place for yourself, passengers in your vehicle, luggage and the vehicle itself. GT Car Tours also requires you to have the appropriate level of breakdown cover in place for your vehicle for those states and/or countries in which we are travelling.

Pricing:

As previously described all-inclusive items are detailed within the tour itinerary and any add on items you require are to be paid for by you. As is the nature of booking events many months in advance your booking may be subject to price variations.

Price variations generally fall into the following categories:

- Third-party variations: GT Car Tours will seek to lock in prices with our vendors and suppliers wherever this is possible. In the event GT Car Tours cannot lock in the price, there may be an additional cost to bear if vendors increase their prices.
- Currency variations for international tours: The price of the tours is calculated at the rate of exchange against the dollar at the time the tour is posted onto the website.
- Government action: Items such as taxes or tolls for which GT Car Tours has agreed to pay may alter without prior notice.

In all the above cases, GT Car Torus will absorb any adverse cumulative cost increases up to 5% of the original fee. Thereafter, it will be your responsibility to pay any additional cost.

Car Livery:

You are not required to place any livery or stickers on the exterior of your car, and you are not permitted to place any number stickers on the exterior of your car. This can in many cases invalidate your insurance and can attract the wrong kind of attention while generally destroying the look of your car. If you do choose to place stickers on your vehicle, GT Car Tours reserves the right to insist on their removal if it is determined to be in any way inappropriate in the sole judgment of GT Car Tours.

Image Rights:

In participating in a tour, you agree to have photographs and cinematic footage taken of you and your property and to allow GT Car Tours, without charge, the use of these images for its website or other promotional purposes such as placing on the GT Car Tours' website, or in magazines, films, documentaries, and other promotional materials. You, of course, are entitled to take your own pictures and film, but in no way can you market these as a representative of GT Car Tours. If you do not agree to these conditions, please inform us in advance of your participation in the event as you cannot make any retrospective claim for invasion of privacy or defamation.

Complaints:

If you feel you have a complaint, either before or during the tour, you agree to immediately notify a representative of GT Car Tours so that your complaint can be addressed as effectively as possible. If upon returning home, you are not satisfied with how your grievance has been attended, please promptly inform GT Car Tours in writing of your complaint.

Liability:

Our liability to you:

- GT Car Tours will endeavor to make sure all parts of your tour that we have agreed to arrange, perform, or provide as part of your contract with GT Car Tours are done so with reasonable skill and care.
- In relation to the supply of goods and services, except as stated in these terms and conditions, GT Car Tours will not be liable to you or a member of your party for any injuries, liabilities, damages or other losses incurred by you or your property. Unless stated otherwise in these terms and conditions, the total liability of GT Car Tours to anyone lodging a claim in relation to any alleged negligent or other tortious act shall not exceed the cost of the tour paid by that person.

Third-party liability:

- Those parts of your tour which involve utilizing the services of third parties (*e.g.*, flights, hotels, ferry crossings) will be governed by the terms and conditions of each individual third party.

Your liability:

- You and the members of your party are responsible for all add-on costs as described elsewhere within these terms and conditions, in addition to items such as fines, penalties, damages and other expenses incurred by you during the tour. If GT Car Tours is in any way held liable to a third for such items or your negligence or other tortious act, you agree to indemnify and hold harmless GT Car Tours, including for any attorney fees and court costs.
- In participating on a tour, you do so voluntarily and in the full knowledge that any accident, injury or other incident to you or third parties as a result of your actions is entirely your responsibility and liability and you therefore agree to indemnify and hold harmless GT Car Tours and its managers, officers, and representatives in full against any claim brought about by you, a member of your party or a third party.

Variations:

From time to time, it may be necessary to amend these terms and conditions to reflect the nature or timing of a particular tour. In these instances, details will be made clear on the itinerary page of the applicable tour under "Special Conditions."

Acceptance of Terms and Conditions:

In booking a tour you are deemed to have read and fully understood the terms and conditions of participation and agree to be bound by them in their entirety. If upon reading these terms and conditions you do not understand any part of them, you must contact GT Car Tours before paying your deposits.
